What are Cloud Apps and how to use them in Alma

Cloud Apps are created by both the Ex Libris user community as well as by Ex Libris staff. You can also easily search, activate and launch Cloud Apps directly from within products such as Alma, Primo VE, Esploro, Leganto and Rapido. During this session we will see how to activate and use the Cloud Apps in general, and look at specific examples of how Cloud Apps can improve the library workflow.

Analytics Data Visualization in Alma and Primo

Data visualization (DV) is a tool built into Alma and Primo VE together with Alma Analytics. DV allows for advanced graphical representation of information and data. By using visual elements such as charts, graphs, and maps, data visualization tools provide an accessible way to see and understand trends and patterns in

data. During this session we will look at specific examples using both Alma and Primo VE.

Introduction to Primo VE

Using and Configuring the Alma General Publishing Profile

The Alma General Publishing Profile allows the institution to publish bibliographic and authority records to third-party systems. Alma publishing includes several features:

-Incrementally published data through files or OAI-PMH (Open Archives Initiative Protocol for Metadata Harvesting).

- Optionally enriching the data with nonbibliographic record data (such as inventoryrelated data).
- -Normalization (reformatting) of the published data.
- -Notification about inventory deletion.

 During this session we will look at these options and publish records using the different options.

P and E Overlap analysis and deselection tools with Alma Analytics
